

Munster Band Backers Raffle Official Rules

The Munster Band Backers Raffle is conducted by Munster Band Backers, a not-for-profit corporation organized under the laws of the State of Indiana.

1. The purchase price of a raffle ticket is \$25. Checks or money orders should be made payable to Munster Band Backers. Purchase may be made in person at Peoples Bank, 9204 Columbia Avenue, Munster, Indiana 46321, or by sending payment to Munster Band Backers, c/o Munster High School, 8808 Columbia Avenue, Munster, Indiana 46321. Cash, check, or money order is accepted. Credit card payments are available through Paypal at www.munsterbandbackers.org. If an entrant's payment is dishonored by the financial institution, the entry will be declared invalid and the entrant will be responsible for any fees incurred.
2. Completed raffle tickets must be delivered to Munster Band Backers at 8808 Columbia Avenue, Munster, Indiana 46321, and must be in the possession of Munster Band Backers by 5 p.m., July 18, 2008, or postmarked by July 14, 2008, in order to insure eligibility for the Munster Band Backers Raffle. Completed raffle tickets received after 5 p.m., July 18, 2008, may not be eligible for raffle drawing and if not eligible, payment for those tickets shall be refunded. Munster Band Backers reserves the right to extend ticket sales, at its discretion, up to the time of the drawing.
3. Purchasers of raffle tickets must be 18 years of age or older and must qualify under Indiana law.
4. First prize shall be \$30,000 in cash or in scholarship form (scholarship may be payable in 4 equal increments for the First Prize only). Second prize shall be \$5,000 in cash or in scholarship form; third prize shall be \$2,500 in cash or in scholarship form; fourth through tenth prize shall be \$500 in cash or in scholarship form.
5. In the event fewer than 2500 tickets are sold by July 18, 2008, Munster Band Backers may cancel the raffle as specified in Rule #11, or modify the raffle and withdraw the first prize, award prizes 2 through 10 and split the remaining net profits (income less expenses) equally between Munster Band Backers and the first prize winner. All prize winners may take their prize as cash or in the form of a scholarship. All proceeds, less prizes and expenses, will benefit Munster Band Backers.
6. Names of the winners will be posted at the Munster High School Band Room, Peoples Bank, and on the Munster High School Band Backers website at www.munsterbandbackers.org. A copy of the list may be obtained by sending a self-addressed, stamped envelope to Munster Band Backers, 8808 Columbia Ave., Munster, Indiana 46321.

7. In the event 3,000 tickets are sold, each ticket has an approximately 1-in-300 chance of winning a prize in the raffle and a 1-in-3,000 chance to win the first prize.
8. Two \$500 Early Bird drawing winners will be determined by raffle drawings. The first drawing will be on March 4, 2008 at the Wilbur Wright Middle School band concert and the second drawing on May 15, 2008 at the Munster High School band concert. The final drawings will be held July 23, 2008, at approximately 7 PM at the Marching Mustang Band Potluck performance held at Munster High School. Winners will be notified within thirty days.
9. The winner of the Munster Band Backers Raffle must make and deliver an election in writing to the Munster Band Backers between the scholarship and the cash prize before 5:00 p.m. Central Daylight Savings time on September 23, 2008. In the event that the winner of a prize does not make and deliver his/her election to the Munster Band Backers at 8808 Columbia Ave., Munster, Indiana 46321 by September 23, 2009, the prize shall be forfeited and the prize monies shall then be awarded to the Munster Band Backers for deposit into its general account.
10. Winners will assume and be responsible for all local, state and federal taxes, including without limitation of all applicable sales, use, luxury, income, and special taxes. Munster Band Backers specifically disclaims all express or implied warranties.
11. In the event fewer than 2500 tickets are sold, Munster Band Backers, at its option, may cancel the Raffle any time before the drawing and, in such event, Munster Band Backers shall return to each participant the full purchase price of the ticket.
12. More than one name may be stated on the registration form; however, the first listed name shall be deemed the "entrant." The Social Security number of the entrant must be provided to claim a prize. Payment or delivery of any prize shall be made solely to the entrant. It is the sole responsibility of the entrant in the multiple party entry to allocate any such prize among the other participants in the multiple party.
13. Payments are not tax-deductible contributions.
14. The decision of Munster Band Backers shall be final on all matters concerning the raffle.
